These are alcohol purchase permits, enabling various people to purchase alcohol. Permits were granted to pharmacists and to ministers (for sacramental wine), etc. With the permits is a territorial register (1892-1894) containing information about issuance of licenses 1000 through 1249.

Sales of alcohol (generally to pharmacies) are recorded in this journal. Purchase of alcohol during Prohibition was by doctor's prescription only and obtained from a pharmacy (sacramental use was also permitted).
