Chapter 133 of the 1921 Laws of Utah created a commission to investigate and report upon revising the system of taxation. Five members were appointed by the governor to make a report to the governor by 1 January 1923. This volume contains the typed minutes of the commission and a copy of their report. The commission was recreated by ch. 99, Laws of Utah, 1929, and a volume of the 1929-1930 minutes also is included.
